1.) Call To Order:

2.) Approval of the May and June 2018 Police Commission Minutes

Motion by Statz, second by Woodly to approve the May and June 2018 meeting minutes. Motion carried.

4.) Budget Report:

Chief Klicko provided information to the Police Commission on the budget for the new records management system. A brief discussion took place.

5.) Incident, Offense and Traffic Reports:
