3. Approve the Minutes of the October 10, 2017 Meeting.

4. Discussion of the 2017 Annual Reports for TID #3

Andrew Bremer presented information from the 2017 Annual Report for TID #3.

Highlights include:

- Created in 2005 and has a mandatory termination date of 2032
- Has a base value of \$161,000
- 2017 Current Value of \$1,205,500
- 2017 Tax Increment Value of \$1,044,500
- 2017 Total Revenues of \$24,437
- 2017 Total Expenditures of \$4,589
- 2017 Year End Fund Balance of (\$21,515)

5. Discussion of the 2017 Annual Reports for TID #4

Andrew Bremer presented information from the 2017 Annual Report for TID #4.

Highlights include:

- Created in 2015 and has a mandatory termination date of 2042
- Has a Base Value of \$16,032,800 (corrected 12-15-17 from \$14,973,000)
- 2017 value of \$16,982,800
- 2017 Tax Increment Value of \$950,000
- 2017 Total Revenues of \$11,183

- 2017 Total Expenditures of \$41,733
- 2017 Year End Fund Balance of (\$209,752)

6. Discussion of the 2017 Annual Reports for TID #5

Andrew Bremer presented information from the 2017 Annual Report for TID #5.

Highlights include:

- Created in 2015 and a mandatory termination date of 2042
- Has a Base Value of \$12,622,800
- 2017 Current Value of \$13,633,300
- 2017 Tax Increment Value of \$838,00
- 2017 Total Revenues of \$3,280
- 2017 Total Expenditures of \$42,700
- 2017 Year End Fund Balance of (\$73,200)
